A water quality report, also known as a Consumer Confidence Report (CCR), provides information about the quality of your drinking water. It's required by the EPA and must be provided annually by public water systems.

This report includes details about your water source, contaminants, compliance with regulations, and our water system contact information.

Cara is joining us as a Customer Service Representative.

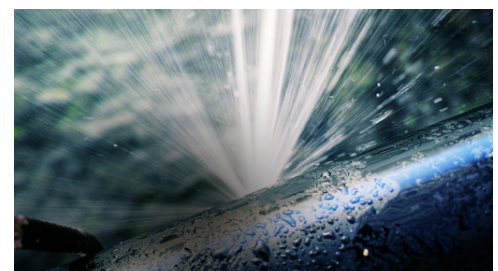

Construction Update

Cash SUD continues to improve our infrastructure to better service our fast growing community.

Completed Projects:

- Line upgrade from 2" to a 6" inch water line on CR 3202 in Lone Oak.

Under Construction:

- Ground storage tank is being painted on Ben Payne Rd in Fate, TX.
- Union Valley pump station to be completed within the next 2 months.

Next Project:

- Line Upgrade from 2" to 4" on CR 1525.
- Line Upgrade from 6" to 12" on CR 2182, CR 2178, CR 2180 and FM 1570



Lead & Copper

The Lead and Copper Rule protects public health by minimizing lead and copper levels in our drinking water primarily by reducing corrosion of plumbing materials. Cash SUD is actively identifying the material of service line that supplies water to your property from the District's water main.

Your cooperation is appreciated as we strive to ensure the safety of our water supply.
